








EPICENTER OF GROWTH

80% of U.S. markets within **3-4 days of transit**








LEADING LOGISTICS








BUSINESS FRIENDLY CLIMATE

- 5.75% corporate income tax rate only applied gross to receipts in Georgia
- Fully funded rainy day fund
- Georgia has a AAA bond rating from all three agencies
- Single factor apportionment based exclusively on gross receipts in Georgia
- Cost below the U.S average and one of the most affordable states in the Southeast
